Enclosed is the \$50.00 REGISTRATION FEE (non-refundable) PLUS the TUITION DEPOSIT (to hold my child's place) credited to the last month of the school year and refundable only until July 1, 2012. I understand absences are not credited and classes cancelled due to snow or any other emergency are not rescheduled. I understand that it is expected that my child will attend the full school year. I understand payment of tuition is due by the 15th of each month starting September, 2012. I also understand payment of tuition is due on time regardless of my child's absence. I understand and will abide by the terms and policies of the school as stated in the Connecticut Farms Church Nursery School Brochure. Complete medical forms and other required forms will be submitted before my child enters school. PROOF of a seasonal FLU shot is also REQUIRED by November 2, 2012. There is a substantial State fine and exclusion of your child from CFCNS for not complying with this State Flu Mandate.
